The mission of the Domestic Violence Coordinating Council is to reduce the incidence of domestic violence and abuse in all its forms.

The Domestic Violence Coordinating Council is a State agency legislatively created in 1993 to improve Delaware's response to domestic violence. The Coordinating Council brings together domestic violence service providers and policy level officials to identify and implement improvements in system response through legislation, education, training, and policy development.

Delaware Code, Title 13, Domestic Relations, Chapter 21

The Domestic Violence Coordinating Council:

- Studies court services and procedures, law enforcement procedures and protocol, and criminal justice data collection and analysis, as it relates to domestic violence.
- Effectually coordinates among agencies, departments, and the courts with victims of domestic violence and abuse.
- Promotes effective prevention, intervention, and treatment techniques based upon research and data collection.
- Recommends standards for treatment programs for perpetrators of domestic violence to the Department of Health and Social Services, Department of Services for Children, Youth, and Their Families, and the Department of Correction.
- Reviews and comments upon legislation relating to domestic violence introduced in the General Assembly at the request of any member of the General Assembly or on its own initiative.
 - And, improves the response to domestic violence and abuse to reduce the incidents thereof.



MESSAGE FROM THE CHAIRS

On behalf of the Domestic Violence Coordinating Council (DVCC), we present the 2008 Annual Report. As Chair of the Council, I would like to personally thank the Honorable Chandlee Johnson Kuhn for contributing her time and talent as Vice Chair and welcome the Honorable Carl C. Danberg as our new Vice Chair. We thank all of our Council members for their leadership and service and welcome our newest member, Margaret Reyes, of the Governor's Council on Hispanic Affairs.

The DVCC had another busy and productive year. We began our work on the issue of Children Witnessing Domestic Violence by joining with CHILD, Inc., to sponsor a one-day lecture event on the topic. Dr. Jeffrey L. Edleson, one of the world's leading authorities on children exposed to domestic violence, was the featured speaker and his presentation was highly rated by the 200 plus participants. In addition to our ongoing efforts, the Coordinating Council plans to spend the next three years focusing on this very important issue.

DVCC staff spent much of the winter months delivering pocket risk assessment notebooks to law enforcement agencies. The Pocket Notebook was developed to aid officers in conducting on scene risk assessments by listing the 21 Risk Assessment Questions and space for notes. With funding from a Violence Against Women Act (VAWA) Grant, 11,500 pocket-sized notebooks were printed. The DVCC staff delivered the Pocket Risk Assessment Notebooks to law enforcement agencies throughout the State and provided approximately thirty trainings to officers on the use of the pocket-sized Risk Assessment tool.

The DVCC was successful in passing several important pieces of legislation; among them, **SB 253** which enhances the harassment and stalking statutes, **HB 371** which adds the offenses of sexual abuse and sexual assault to the state crime victim compensation statute, and **HB 486** which adds a \$15 fee on to all certified copies of marriage licenses/certificates issued. The money raised will be used to fund domestic violence victim service programs. We would like to acknowledge the Sexual Assault Network of Delaware and the Victims' Rights Task Force for their contributions.

The Coordinating Council members and staff worked closely with the advocacy community, victim services, elected officials, law enforcement, schools, the Children's Department, the Department of Justice, the courts, corrections, treatment providers, and others to accomplish our goals during the past year. For the coming year our goal is a simple one: to continue to collaborate with our partners in working to improve Delaware's response to domestic violence.

Cheryl Cooper Trainer/Educator It is our goal to improve Delaware's response to domestic violence, to better assist the innumerable victims, who suffer assaults and abuses everyday. Towards that end, the Domestic Violence Coordinating Council's Legislative Subcommittee introduced and supported several bills which were passed by the 144th General Assembly. Notable features of the new bills include:

House Bill #486 adds a \$15.00 fee on all certified copies of marriage license/certificates issued in Delaware. The money establishes a domestic violence fund to support domestic violence victim service programs in Delaware. This is in response to cuts in federal funding of the Violence Against Women Act.

Senate Bill #253 enhances the harassment and stalking statutes of the Delaware Code to better protect Delaware citizens. House Bill #371 amends the State's crime victim compensation statute by adding the offenses of sexual assault and sexual abuse and provides exceptions for the reinvestigation of cases involving child sexual abuse by an adult, waives the reporting requirements for cases involving children who were victims of sexual assault or abuse by an adult and mandates the establishment of streamlined procedures to allow for the provision of psychological services for victims who were minors at the time of the offense.

I would like to thank Senator Blevins, Representative Hudson and Senator Sorenson for their unwavering commitment to improving Delaware's response to domestic violence. I would also like to thank our many colleagues for coming to the table to guide and support our efforts to reduce domestic violence in Delaware.

A final thanks to the extremely talented, creative and hard working staff of the Domestic Violence Coordinating Council; Laura, Cindy, Cheryl and Kenzel, Great job!


LEGISLATIVE UPDATES - STATE OF DELAWARE

The following bills were passed by the 144th Delaware General Assembly:

Senate Bill (SB) 253 w/SA 1

AN ACT TO AMEND TITLE 11 OF THE DELAWARE CODE RELATING TO HARRASSMENT AND STALKING

This Act enhances the harassment and stalking statues to better protect Delaware Citizens. Changes included the number of incidents required to be eligible for stalking and the penalty level.

Date Passed: 6/30/2008

House Bill (HB) 486 w/HA 2, HA 3, HA 4

AN ACT TO AMEND TITLE 11 OF THE DELAWARE CODE RELATING TO MARRIAGE LICENSES

This legislation adds \$15 fee on to all certified copies of marriage license/certificates issued. The money raised will fund domestic violence programs.

House Bill (HB) 371 w/HA 1, HA 1 to HA 1

AN ACT TO AMEND TITLE 11 OF THE DELAWARE CODE RELATING TO COMPENSATION FOR INNOCENT VICTIMS OF CRIME

This Act amends the State's crime victim compensation statute by adding the offenses of sexual assault and sexual abuse. This will allow for provisions of psychological services for adults who were child victims of sexual abuse or assaults.

Senate Bill (SB) 192

AN ACT TO AMEND TITLE 13 OF THE DELAWARE CODE RELATING TO THE DOMESTIC VIOLENCE COORDINATING COUNCIL

This legislation makes a minor change to the composition of the Domestic Violence Coordinating Council to ensure that the advocacy community continues to have a strong representation on the Council.

LEGISLATIVE UPDATES - STATE OF DELAWARE

Senate Bill (SB) 110

AN ACT TO AMEND TITLE 25 OF THE DELAWARE CODE RELATING TO RETALIATORY ACTS

This Act amends the Delaware Landlord-Tenant Code by ensuring that tenants who are domestic violence, sexual offense or stalking victims are protected from eviction when they seek services relating to their status as a victim.

Date Passed: 6/21/2008

Senate Bill (SB) 251

AN ACT TO AMEND TITLE 11, CHAPTER 94 OF THE DELAWARE CODE RELATING TO THE VICTIMS' BILL OF RIGHTS

This legislation adds a new section to the Victims' Bill of Rights which states no law enforcement officer, prosecuting officer or other government official shall use a victim's refusal to submit to a polygraph examination or other truth telling device as a condition for proceeding or not proceeding with the investigation of an alleged sex offense against the victim.

Date Passed: 6/24/2008

House Bill (HB) 424 w/HA 1

AN ACT TO AMEND TITLE 11 OF THE DELAWARE CODE REGARDING VOLUNTARY AND MANDATORY TESTING OF OFFENDERS CONVICTED OF CERTAIN SEX CRIMES

This Act amends Title 11 of the Delaware Code, Chapter 39, Subchapter 11 requiring the defendant to submit to HIV testing at the request of the victim if the defendant has compelled the victim to engage in sexual activity either through force or threat of force.

DOMESTIC VIOLENCE STATISTICS



In calendar year 2007, as reported by the State Bureau of Identification, the total number of domestic violence incidents in Delaware was 28,423 (combined criminal and non-criminal). That is a .01% decrease over 2006 reported incidents, but a 5.7% increase over the number reported in 1998.


















NOTE: Delaware has ten years of domestic violence statistics (1998 -2007). A review of the statistics published by the State Bureau of Identification for calendar years 1998 through 2007 reveals some interesting information and trends.

DOMESTIC VIOLENCE STATISTICS

In calendar year 2007, the total number of domestic violence criminal incidents was 16,265. The total for 2007 reflects an decrease of 45 incidents from the 16,310 reported in 2006.




In 2007, out of the 16,265 criminal incidents, 16% resulted in injury.




INTIMATE PARTNER STATISTICS

Intimate partner cases include current and former spouses and current and former dating couples. Intimate partners may be of the same gender. In calendar year 2007, as reported by the State Bureau of Identification, the total number of criminal domestic violence incidents involving "intimate partners" was 8,163. This number represents 50% of the total criminal domestic violence incidents.




The ratios of reported victims of domestic violence incidents in the calendar year 2007 were 6,217 (76%) female and 1,977 (24%) male.



INTIMATE PARTNER STATISTICS


In 2007, there were 8,163 intimate partner domestic abuse incidents reported. Of those incidents, less than 13% were reported to have involved drugs or alcohol.

*These statistics were obtained from Delaware Criminal Justice Information System (DELJIS).



In 2007, there were 154 reported dual arrests. In the past five years, the average is 136. This is a vast increase from last year when there were 85 dual arrests.

*2004 data for this category was unavailable.




Dual arrest typically signifies a failure to identify the primary aggressor and may hold the victim accountable for the abuse.


PROTECTION FROM ABUSE STATISTICS

Family Court processed 3,130 Protection From Abuse Petitions (PFA), Statewide in 2007.

*The 3,130 does not include the additional 552 Ex-Parte Orders (Temporary 10 Day Emergency Order) issued in 2007.

In 2007, there were 1,695 Final Protection From Abuse Orders issued Statewide. Protection Orders issued may provide the following relief for victims: no contact with the Petitioner, exclusive use of the home or possessions, temporary custody, child support or support for the Petitioner, payment of expenses, surrender of firearms, counseling, and other relief that may help to prevent future violence.






PROTECTION FROM ABUSE STATISTICS

Of the 3,130 petitions processed, 1,695 PFA Orders were issued. The remaining 1,435 petitions were dismissed. A Protection From Abuse petition dismissal can occur one of three ways -

- The petitioner fails to appear for the hearing (744),
- Petitioner voluntarily withdraws the petition before the hearing (534),
- Or, Dismissed following a hearing where abuse was not found by a preponderance of evidence (157).



What is an Order of Protection From Abuse?

An Order of Protection From Abuse is an order of Family Court ordering someone to stop abusing another person, and may include other relief, such as ordering the abuser to stay away from the person being abused. Abuse is defined as any threatening or harmful conduct including serious emotional harm.

Who can file for Protection From Abuse?


Spouses, ex-spouses, family members, persons of the opposite sex who lived together when the abuse occurred, and unmarried persons who have a child/children in common may file for an Order of Protection From Abuse. Also, the Division of Child Protective Services acting in the interest of a minor child may file a petition alleging domestic violence; or the Division of Adult Protective Services acting in the interest of an infirm adult may file a petition alleging domestic violence.




In 2007, Governor Ruth Ann Minner signed into law a bill amending the definition of parties considered protected under the State's domestic violence statute. This change reflects substantive relationships not previously included under the law, such as dating relationships and same sex relationships.

DOMESTIC VIOLENCE HOTLINE STATISTICS


In 2007, there where 2,767 calls to the domestic violence hotline in New Castle County. This is an increase of 434 calls from year 2006.




In 2007, there was a total of 686 calls to domestic violence hotlines in Kent and Sussex Counties. This is a decrease of 65 calls since year 2006.





SHELTER STATISTICS

In New Castle County, 292 individuals were provided shelter in 2007. Of the 292 individuals provided shelter, 162 were women and 130 were children.



In Kent and Sussex Counties, the total number of individuals sheltered in 2007 was 245. Of the 245 provided shelter, 112 were women and 133 were children.



SHELTER STATISTICS

In 2007, 537 women and children received shelter services in Delaware. The average number of individuals sheltered in Delaware's domestic violence shelters since 1998 is 551.





Delaware Shelters

There are five shelters located throughout the State of Delaware. Women and their children find a temporary home where they can receive assistance with safety planning and information on criminal and civil process, participate in support groups and individual counseling, and find assistance in locating employment and permanent housing.



Probation & Parole has a specialized DV Unit in each county. Domestic violence cases are assigned to the DV Units based on criteria, including offenses, victim/offender relationships, and active PFA orders. The philosophy of the DV Unit is to hold the offender accountable and to maintain victim safety. In addition to specialized DV Probation Officers, each office has a Domestic Violence DV Victim Liaison.

FATAL INCIDENT REVIEW TEAM

Fatal Incident Review Team

Staff: Laura M. Giles

A significant part of the Domestic Violence Coordinating Council's work is to track domestic violence fatalities and review the circumstances of those cases. The Domestic Violence Fatal Incidents Review Act statute, signed into law in June 1996, established a Fatal Incident Review Team to investigate and review the facts of all domestic violence related fatalities, both homicides and suicides that occur in Delaware. To avoid duplication of efforts, the Fatal Incident Review Team and the Child Death, Near Death, Stillbirth Commission held it's first "Joint Review" in February 2007. Members of both Review Teams will share information when the death of child is a result of domestic violence.

The ultimate purpose for reviewing domestic violence fatalities is to prevent such deaths in the future. By conducting system audits of State agencies and private organizations that had contact with the deceased victim and or the alleged perpetrator, the system's response to domestic violence may be improved. Steps may be taken to prevent future deaths and injuries by making changes to existing policies and practices and by identifying gaps in services and developing programs to fill those gaps.

Confidentiality is maintained throughout the review process and is required by statute. The records of all reviews are confidential and are exempt from the provisions of the Freedom of Information Act in Title 29 of the Delaware Code. Reports published by the review team include only aggregate data and do not identify specific cases.

Although the domestic violence fatality reviews are retrospective in nature, their purpose is prospective. The reviews focus on identifying trends and obstacles in service delivery, assessing the adequacy of agency interventions and, most importantly, developing recommendations for policies and practices aimed at reducing domestic violence deaths in Delaware.

Team members review between ten and twelve cases each year. The review team members are established by statute, and range from Chief Judge to victim advocate. Although the review team members represent different agencies and interests, they focus on the common goal of developing recommendations to reduce domestic violence in Delaware and prevent future deaths.
